Prof. N.R. Sharma, Dean Academics, Ms. Rupa Gupta, Joint Director (MIER) and Sh. B.L. Bhat, Asstt. Registrar also attended the meeting as special invitees.

At the outset Prof. Adit Gupta welcomed the members of the newly constituted Governing Body in the meeting. He informed the members about the sad demise of Dr. Arun K. Gupta, Chairman, MIER Group of Institutions on 31-01-2021. The members paid tribute to the Chairman and lauded the role he played in the development of education in the Union Territory of Jammu & Kashmir. The members observed one minute silence to pay homage to the departed soul. Thereafter, Prof. Adit Gupta, took up the agenda items for discussion.

8. Prof. Adit Gupta, Principal put forth the proposal of the College to start some new programmes from the coming session. The programmes like the 4-Year Integrated Teacher Education Programme (ITEP- B.A.-B.Ed./B.Sc.-B.Ed.) and the 3-Years B.Ed.-M.Ed. Integrated programme shall be started after the college gets recognition from the National Council of Teacher Education (NCTE). He further apprised the members that the College proposes to start One-Year Advanced Diploma in Guidance and Counselling along with One Year Diploma in Elementary Education from the year 2021/2022. Besides the teacher education programmes, the college also plans to start multi-disciplinary courses such as B.A. Psychology (Honours) and B.A Economics (Honours) etc. to cater to a wide variety of students.

The members appreciated the proposal of the College to start the integrated courses as per the NCTE Regulations, keeping in view the New Education Policy of the Govt. of India and Resolved that the College be allowed in principle to start the 4-Year Integrated Teacher Education Programme (ITEP- B.A.-B.Ed./ B.Sc.-B.Ed.) and the 3-Years B.Ed.-M.Ed. Integrated programme.

Resolved further that the Undergraduate courses in Psychology and Economics along with the One Year Advanced Diploma Course in Guidance and Counselling and One Year Diploma in Elementary Education be started from the session 2021/2022. The members also suggested that the college may start innovative programmes at the Master's level such as the Master's in Education (Science Education / Mathematics Education) to cater to the requirements of teachers in these areas.

It was also suggested that the College may carry out a trend analysis to ascertain the market requirements and preference of students so that job-oriented and skill enhancement courses could be started in a phased manner.
