

The IQAC devised a structured questionnaire where online feedback on the curriculum was obtained from the faculty.








3. The curriculum is need based


4. The curriculum of study contains sufficient number of optional courses


5. The course content is followed by corresponding reference material


6. The curriculum has good balance between theory and practical aspects




8. The new topics added in course increased my knowledge and broadened my perspective in the subject






11. I have the academic freedom to adopt new techniques/strategies of teaching such as seminar presentations, group discussions and learners' participation




13. The length of the curriculum is appropriate keeping in view the number of teaching days available


