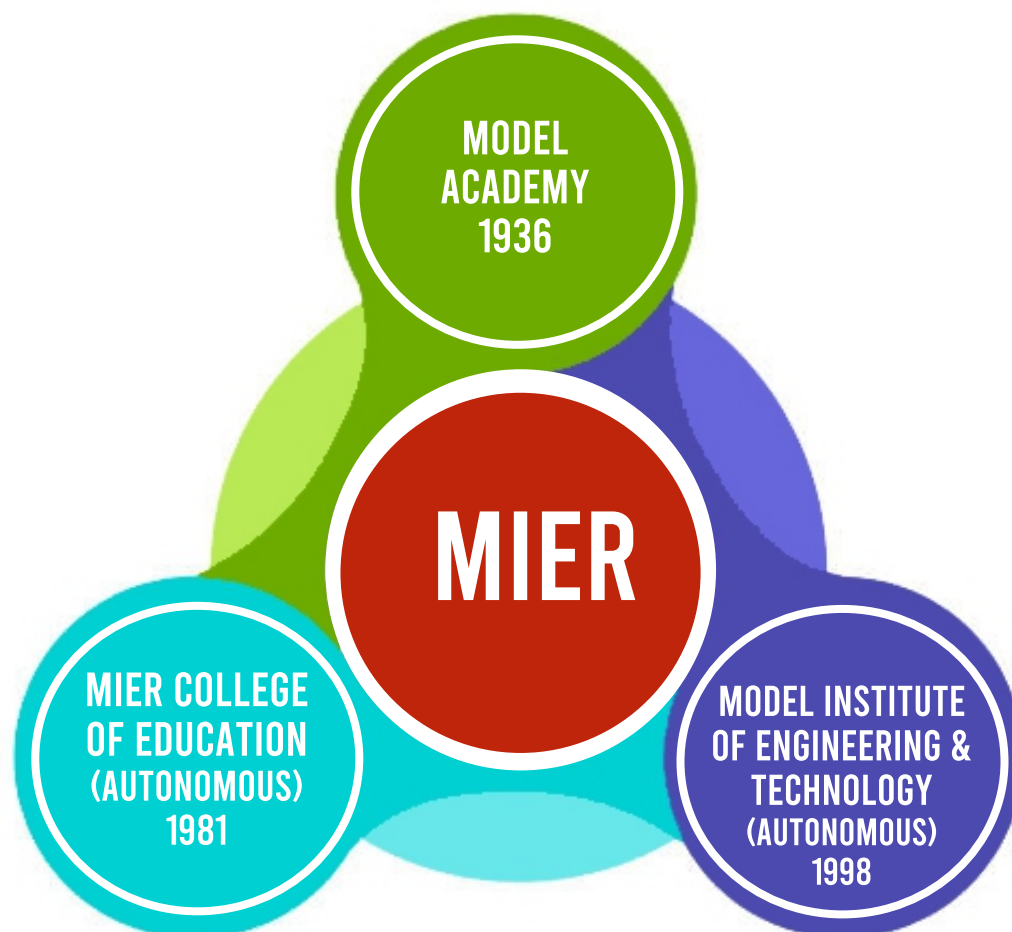
# About MIER

This robust structure ensures a well-managed, future-oriented, and student-centric learning environment at MIER College.

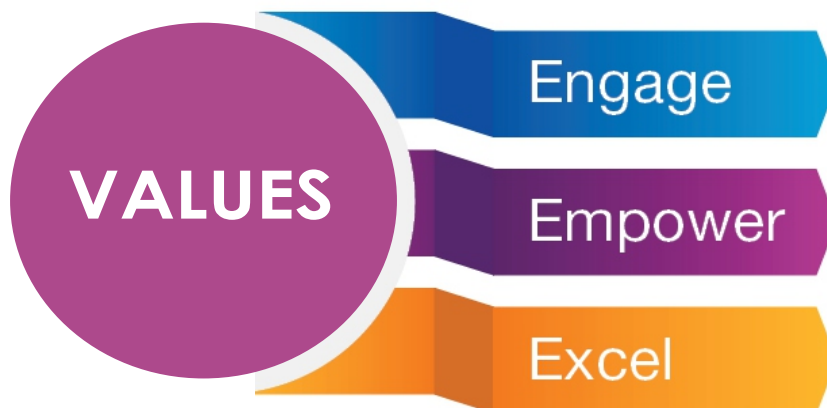

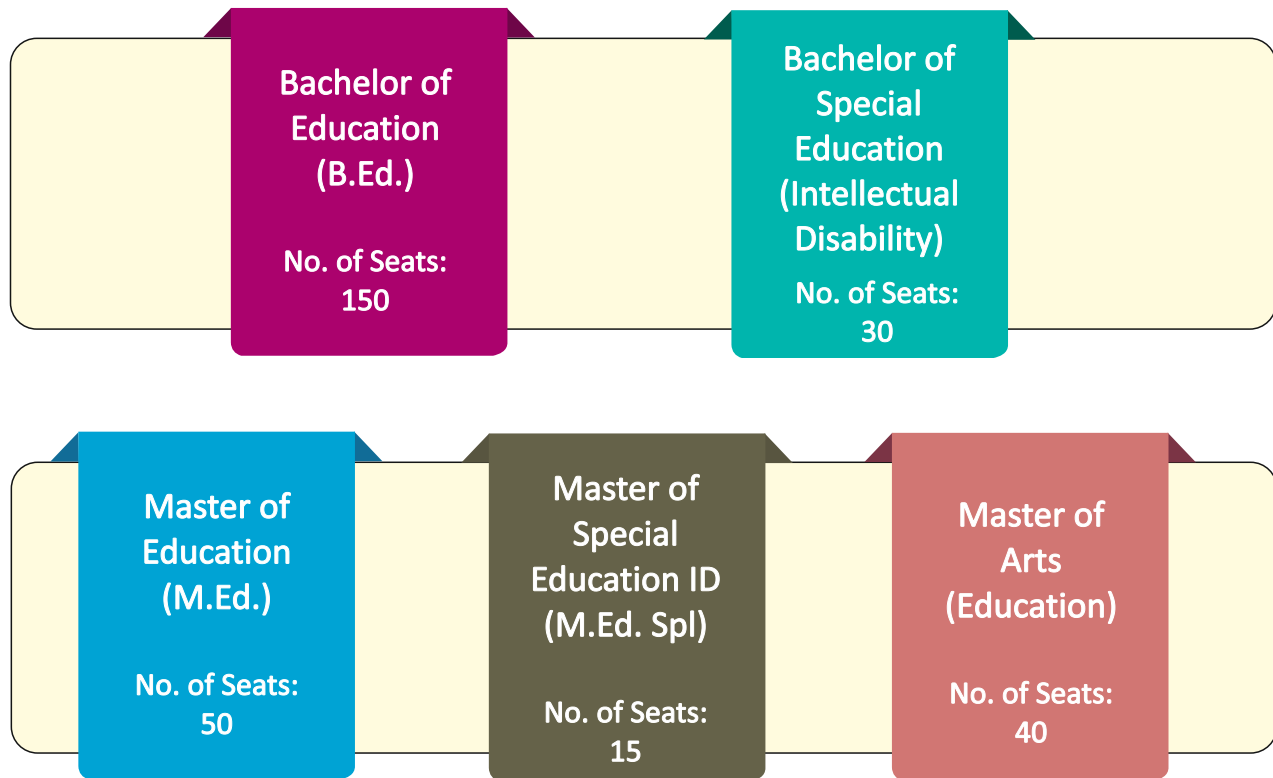

# Inclusive School

MIER College of Education under the auspices of the School of Education, Department of Special Education started a Special cum Inclusive school in the year 2013 at Model Academy, the Experimental School of the College for educating students with special needs. The idea behind setting up of Inclusive school was to ensure that students with special needs gain access to information, knowledge, skills and receive quality education. It has in turn facilitated the parents of children with special needs to have acceptance of their wards in society a reality. The Inclusive School focuses on teaching and preparing students with diverse learning disabilities so that they can interact with regular students in the school from time to time there by being included in the main school setup.

## **FACULTY**

The faculty of Inclusive School is trained in B.Ed. Special Education and have the expertise in adaptive curriculum, alternate methods of teaching, differentiated instructions to provide assistance and support through Individualised Education Plans (IEP). The faculty are trained to deal with a wide range of disabilities among students ranging from Down syndrome, Autism, Physically Challenged, Intellectual Disability (ID) as well as Learning Disabilities (LD).

## **SALIENT FEATURES**

The Inclusive school offers barrier free, child friendly, gender-sensitive, comfortable and safe environment for students with special needs to pursue their education.

### **1. Resource Room Setup**

The inclusive set up provides resource room services where students from the regular school with educational/learning difficulties, such as specific learning difficulties in Reading (Dyslexia), Math (Dyscalculia) , Writing (Dysgraphia) etc. are pulled out of their classrooms and given direct, specialized instruction, academic remediation and assistance after school hours by the special teachers.

### **2. Rehabilitation Centre**

The Rehabilitation Centre on campus provides various services such as Physiotherapy and Pre-Vocational Training. It has several machines and devices to assist students in improving their gait, posture, walking and moving from one spot to the other with assistance by a trained physiotherapist. Music therapy sessions are also conducted for students.

### **3. Medical Check Up**

Medical check-up of students with special needs is done twice in a year by specialists/doctors. It includes routine physical check-up measuring height, weight, checking of teeth and general hygiene of the children besides any other problem being faced by these special children.

### **4. Life Skills**

The instruction in inclusive school includes a lot activities of daily living (ADL) which are designed to provide children with skills they need to function in their everyday life and make them more independent and self-reliant.

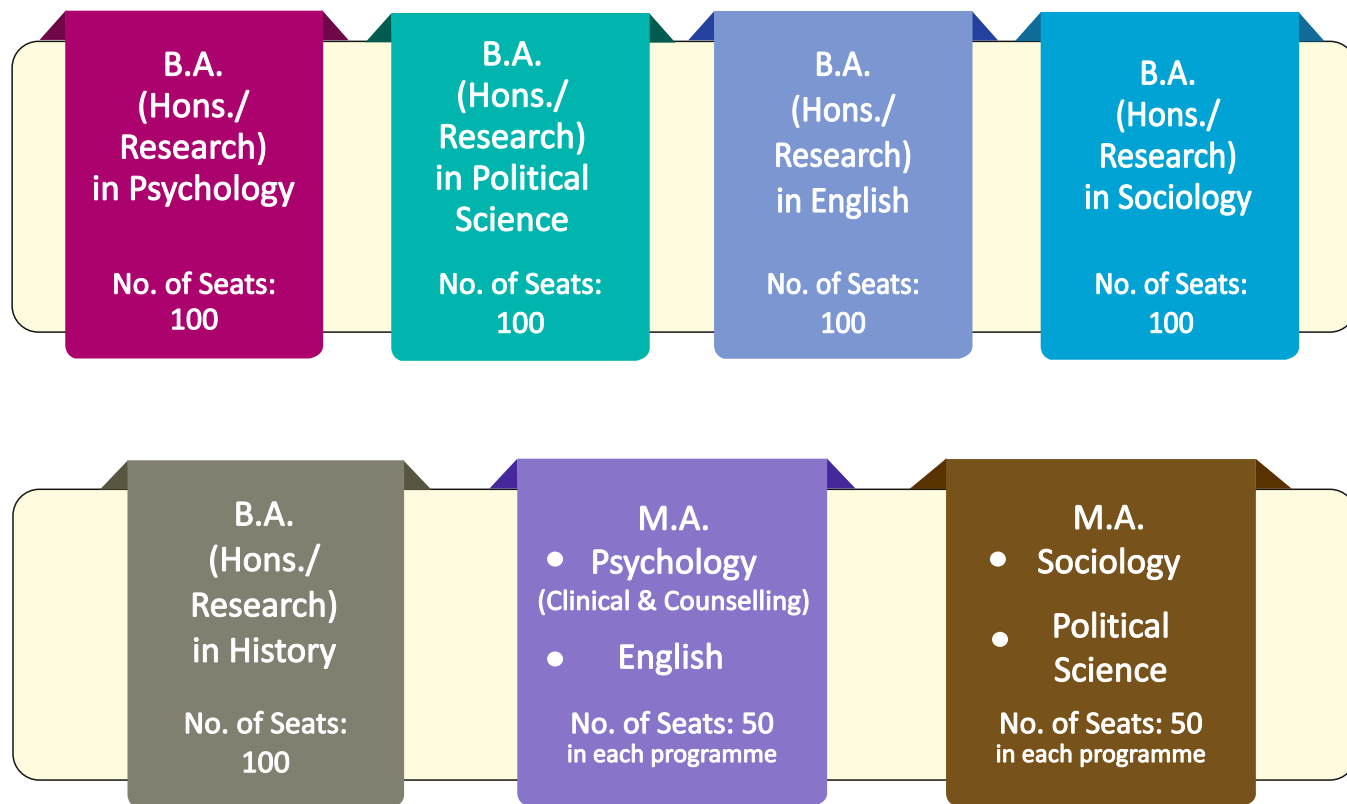

# Admissions Information

## SCHOOL OF EDUCATION

The candidates seeking admission to all programmes in the School of Education are required to register themselves online on the college website [www.miercollege.in](http://www.miercollege.in) and fill up the online application form as per procedure explained on the portal. These programmes shall be of two years duration comprising four semesters each.

### ELIGIBILITY

The eligibility criteria for taking admission in these programmes are as per the guidelines of the regulatory and statutory bodies such as UGC, NCTE and RCI and shall be done on the basis of Common University Entrance Test (CUET PG). The criteria is available on the college website.

### ATTENDANCE

A student shall be eligible for End-Semester Examination if he/she has attended not less than 80% of the lectures delivered in theory including seminars, tutorials etc. in each course and 90% of the internship/field work etc. For M.A. Education Programme, the attendance criteria is 75%.

## SCHOOL OF SOCIAL SCIENCES AND HUMANITIES

The candidates seeking admission to all programmes in the School of Social Sciences and Humanities are required to register themselves online on the college website [www.miercollege.in](http://www.miercollege.in) and fill up the online application form as per procedure explained on the portal. These programmes shall be of four years duration comprising eight semesters each.

### Eligibility

The eligibility criteria for every programme offered at the UG/PG level is as per the guidelines of University of Jammu and shall be done on the basis of Common University Entrance Test (CUET UG/PG). The criteria is available on the college website.

### ATTENDANCE

A student shall be eligible for End-Semester Examination if he/she has attended not less than 75% of the lectures delivered in theory including seminars, tutorials etc. in each course and 90% of the practical work etc.

### AWARD OF DEGREE

The Degree shall be awarded to the successful candidates by the University of Jammu. However, the conduct of examination, issuance of Marks Certificates, Provisional Certificates and Migration Certificates shall be done by the College.

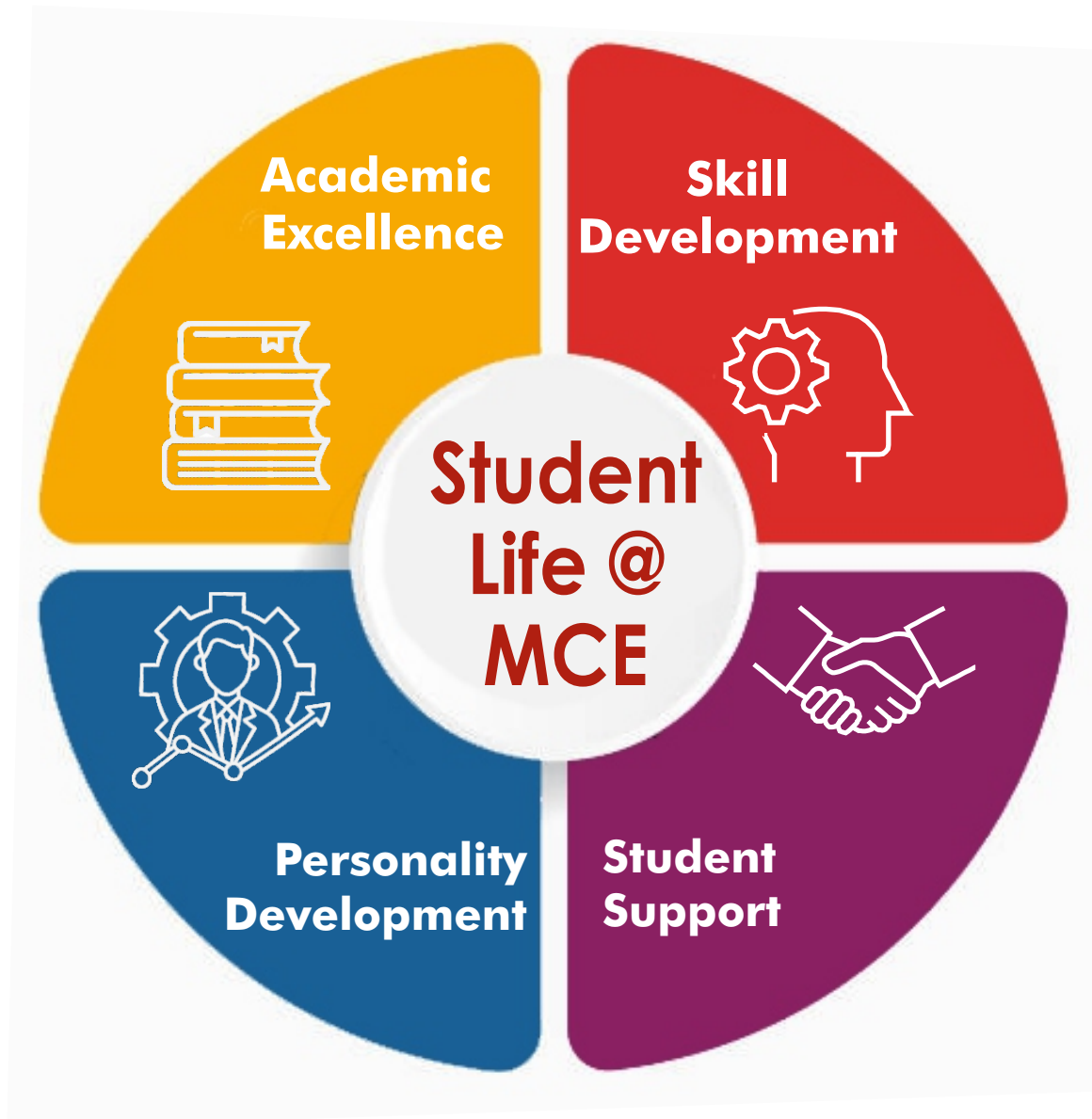

# Rules & Regulations

Students are requested to carefully read all the rules and regulations contained in this brochure and follow these in letter and spirit. After the admission of candidates, it shall be presumed that all rules have been properly read by students.

1. Students are expected to evince a high sense of discipline and good behaviour worthy of a reputed co-educational institution during their period of study in the College.
2. All students shall adhere to the curricular framework adopted by the College as per NEP 2020 guidelines.
3. Students are expected to follow the timings, schedule of activities and calendar framed for different programmes and take part in curricular and co-curricular activities as per instructions of their teachers and authorities.
4. A student is required to appear in all the internal assessment examinations. Failure to appear or abstain from these exams will lead to disciplinary action against the student.
5. Students who do not meet the programme's minimum attendance criteria shall not be allowed to sit in the final examination.
6. No student of the College shall appear in any examination of any University/ Institution as long as he/she is a student of MIER College. However, with prior approval from the College authorities, they may be allowed to enroll in another programme and take its exams concurrently under the permissible statutes/rules and regulations.
7. All students are expected to perform some duties/activities in the College/ Institutional functions like NSS Activities and other socially useful productive work. Refusal to participate in these activities and unwillingness to come for rehearsals etc. before and after College time or during holidays etc. shall be dealt with strictly.
8. Students in the college have to wear uniform as prescribed by the College, compulsorily on specified days, functions and during the days when Teaching Practice is on.
9. Students are expected to follow instructions as are notified from time to time. The Head of the Institution can impose fine, suspend a student and in serious cases, even rusticate or expel him/her from the College. The Head of the Institution is the final authority in all such cases. Strict disciplinary action shall be taken against students who remain habitually absent or irregular or who do not appear in the examinations/tests conducted by the College from time to time. A student remaining on unauthorised absence shall be liable to be struck off the rolls.
10. Candidates applying for withdrawal of admission shall be governed by the rules in vogue regarding cancellation of admission in the College.
11. Students will not leave the College during College hours without due permission. No student will be allowed to meet visitors/outside during the college hours.
12. Candidates will have to take a written permission when proceeding on leave of any kind from the college authorities. An unauthorised absence on any count shall, therefore, tantamount to

cancellation of admission to the course.

13. No student of the College shall accept or retain full time or part time job during the period of his/her study in this institution.
14. Students are expected to uphold the highest standards of discipline and conduct themselves appropriately when representing the college at events, educational visits, field trips, picnics, excursions, and similar activities. Failure to comply with these standards may result in disciplinary action in accordance with the college's disciplinary procedures.
15. The students shall not take part in any political activity, nor shall they indulge in any subversive and anti-social activity.
16. Lodging complaints for redressal of any grievance by students with persons other than the designated college authorities is strictly prohibited. Students who flout this and / or incite others for strikes etc. or adopt means to publicize the issue at different levels and without the prior permission of the Principal will invite disciplinary action against them which may include fine, suspension or even rustication after an official enquiry by the college authorities.
17. Ragging is strictly prohibited. It is a cognizable offence and could culminate in punishment such as fine, expulsion or even rustication and jail after an official enquiry. A ragging committee is constituted to monitor the menace.
18. Committee Against Sexual Harassment (CASH) is in place in the college as an instrument for addressing issues/grievances/cases of sexual harassment and recommending their redressal.

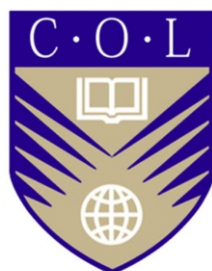
