
#### **DATA COLLECTION AND ANALYSIS**

An online feedback form was created through **Performance Insight-360 (PI-360**), Quality Analytics Framework and sent to the faculty. Responses were received from 20 faculty members. To arrive at comprehensive results, percentages have been calculated. For effective presentation of the data, tables and graphs have been used. Questions were based on a 5-point Likert scale: 1: Strongly agree, 2: Agree, 3: Neutral, 4: Disagree and 5: Strongly disagree.

#### A. The question-wise analysis of the feedback is given below:


1. The curriculum of the programme has been revised as per the guidelines of NEP 2020




















# 12. The curriculum provides an opportunity for incorporating different methods of teaching for course delivery


# 13. The curriculum provides scope for integrating technology into the teaching and assessment process




## 15. The curriculum enhances the employability prospects of the students

#### **B.** Descriptive Feedback

Overall, the feedback analysis highlighted several strengths of the curriculum, along with areas for improvement. Faculty members appreciated the clear connection between course content and desired outcomes, noting that it effectively prepares students for their future careers. 40 percent of the faculty strongly agreed and 60 percent agreed with curriculum satisfaction and delivery. A few suggestions for improvement have been given by the faculty:

- 1. Different Assessment strategies may be adopted in addition to theory exams.
- 2. The collection of books in the library for certain courses/topics need to be increased.
- 3. There is a Scope to add field trips, practical sessions and self-directed learning.

#### Follow-Up Action:

The analysis shall be submitted to the Principal. A meeting shall be convened by the Principal to discuss the feedback and an action taken report of the feedback shall be prepared.

The following action taken report has been prepared based on the decisions taken in the meeting:
